Prior to officially responding to the serious and potentially libelous allegation/s against the PRBoA, as contained in the subject PRBoCE letter signed by its Chairman, Angel L. Lazaro III, Ph.D. (reference Attachment), the PRBoA is requesting the official PRC **confirmation** that said letter has **fully complied** with **PRC Office Order No. 2007-193** dated August 1, 2007 (the “**Order**”).

Due to the possible legal implications (and the possible legal action that the PRBoA may be constrained to take against the PRBoCE), the PRBoA specifically requests official PRC **confirmation** as regards the following:

- 1) whether the subject letter was drafted, reviewed and/or amended by **Atty. Daza**, appointed lawyer for the PRBoCE **prior to** its release to the DILG, the PRC Chairperson, the DPWH, the PICE and the UAP, in full compliance with **Section 1.2** of the Order;
- 2) whether the letter was reviewed or amended by **Atty. Mamalo** prior to its release in compliance with **Section 1.2** of the Order; and
- 3) whether the letter was reviewed or amended by **Atty. Almelor** prior to its release in compliance with **Section 1.2** of the Order.

Failing the above, the PRC must immediately institute the appropriate sanctions against the PRBoCE and its Chairman for non-compliance with the Order and move for the official recall of the said letter as it may have been released in clear and willful violation of PRC protocol/ procedures. The veracity of the allegation/s is beside the point in the interim as what the PRBoA is initially ascertaining is the PRBoCE compliance with the Order.
